- (b) Grant request to Cheveley Parish Council: a formal request will be made to Cheveley Parish Council for a grant of £7,500 to cover the Charity's expenses for the year 2017/18, on the understanding that all expenses already met by the Parish Council in this financial year will be deducted from this amount AGREED.
- (c) Reinstatement of Charity bank account: it was agreed to open a separate bank account for the Charity and Lloyds Bank was suggested as a possibility. The Secretary will investigate further and submit an application as soon as practicable – AGREED. Ian Jackson, Sallie Thomas and Tracey Peel will be the signatories – AGREED.
