4. Approval of Minutes of the Meeting held on 8th January 2019 – AGREED and signed by the Chairman.

5. Matters Arising including reports from the Secretary and Trustees.

Report from the Secretary NOTED as follows:

- 1. Green Wood Tree Surgery completed the recreation ground tree works week beginning 21st January.
- 2. Cllr Elbrow has been issued with a full set of keys to the pavilion. Cllr Marvin's key to the left-hand store padlock has now been replaced.
- 3. The Charity's accounts for the year ended 31st March 2018 were uploaded to the Charity Commission website on 27th January.
- 4. The contact address for the recreation ground has been updated with HM Land Registry. The two addresses held are the Clerk's and the Chairman of the Parish Council.
- 5. The Secretary queried the Wave bill (pavilion water) as the volumetric charge was very high. Wave explained that a true meter reading had been taken on 13th December 2018 and this bill was a 'catch up' on previous estimated readings being too low. The bill should return to a more usual level next time.

7. Pavilion & Recreation Ground Matters

- (a) To consider insurance settlement re: recreation ground wall repair following road traffic collision revised quotation received: it was AGREED to a cash settlement with the insurance company based on the revised quotation of £5,209.00.
- (b) To note correspondence from resident re: tree works on the recreation ground NOTED.
- (c) To consider quotation from Fire & Safety Solutions for the repair of 5 emergency lights at the pavilion the quotation for £157.80 +VAT was accepted and AGREED.
- (d) To consider information re: Fields In Trust (FIT) registration of recreation ground Sheila Marvin will arrange a site visit and draft an application to FIT.
- (e) Pavilion improvements report form public consultations: the results of the consultation will be collated and analysed and reported to the March meeting.
- (f) To consider report from Green Wood Tree Surgery- results of PICUS testing on 3 trees, and consideration of quotation to carry out work as recommended: it was AGREED to carry out all recommended work and to accept the quotations as follows: -
 - Beech fell to ground level, £2,190 +VAT.
 - Horse Chestnut x 2 reduce lateral limbs £1,040 +VAT.

It was agreed that the Beech should be felled as soon as possible and before leaves appear. The trunk will be left on site near to the wall in the wild area. A notice will be placed at the recreation ground informing residents that the Beech must regrettably be felled for safety reasons. Work on the Horse Chestnuts should take place at the same time if possible, or in the Autumn. Green Wood Tree Surgery will also be asked to erect the tyre swing on an Oak at the bottom corner of the field.

(g) Removal of dumped rubbish at the recreation ground – a response is awaited from ECDC regarding possible costs of removal.
