- a. Vehicular height barrier and gates to receive update it was agreed that the new gates look good. However, it was noted that the opening mechanism is at the wrong side which makes access slightly trickier.
- b. Car park perimeter to receive update the new hedging has now been planted. It was noted that it will need watering in dry periods.
- c.
